

AACR Terms & Conditions for All Philadelphia Marathon Weekend Races

Fundraising Requirements

All AACR Runners for Research team members participating in the AACR Philadelphia Marathon or other Philadelphia Marathon Weekend Races (Dietz & Watson Philadelphia Half-Marathon, Rothman Orthopaedics 8K) with a bib secured from the American Association for Cancer Research (AACR) are responsible for raising a minimum amount by the deadline of race day for each race, as outlined below:

- **Rothman Orthopaedics 8K:** Minimum Fundraising Amount: **\$500**; Due Date: November 22, 2025
- **Dietz & Watson Philadelphia Half-Marathon:** Minimum Fundraising Amount: **\$750**; Due Date: November 22, 2025
- **AACR Philadelphia Marathon:** Minimum Fundraising Amount: **\$750**; Due Date: November 23, 2025

The deadlines for raising the minimum amount are final unless otherwise stipulated by AACR manager and agreed to by participant.

In the event the participant does not meet the minimum fundraising requirement by the dates outlined above, the American Association for Cancer Research will charge the balance owed to their credit card on November 26, 2025. Credit cards will not be charged if fundraising minimum is met.

Race Registration

Upon registering on the AACR's Philadelphia Marathon Weekend campaign page and agreeing to these terms and conditions, AACR Staff will provide the participant with a code for participant's race of choice via email to be used by participant on philadelphiamarathon.com within 3 business days.

After AACR has provided the code, it is the participant's sole responsibility to complete the race registration process on philadelphiamarathon.com by October 24, 2025. Failure to do so may result in the loss of registrant's bib.

Cancellation Policy

After registration on AACR's campaign platform, participant will be responsible for raising the minimum for their chosen event even if participant chooses to cancel their participation for ANY reason, including but not limited to injury, unless their entry is able to be replaced by another participant before October 24, 2025. Cancellations will not be accepted after October 24th, and registrants will be responsible for the full amount of the fundraising minimum after that date.

Donations and Fundraising

Any donations received by the American Association for Cancer Research will not be returned. Matching gifts **DO NOT** count towards the minimum under any circumstances. If for any reason the participant is not able to participate, but reaches their fundraising minimum, they may be able to defer their entry to the following year if AACR and the Philadelphia City Fund approve the request.

Release and Contribution Agreement

In consideration of accepting this entry, participant hereby for themselves, heirs, executors, and administrators, waive and release any and all rights and claims for damages they may have against the AACR, other foundation consultants, The Philadelphia City Fund, and event sponsors for any and all injuries suffered or sustained in said event, in the training and planning sessions for said event, or travel to and from any of the preceding.

Participant attests and certifies they are physically fit, will sufficiently train for competition in this event, and a licensed medical doctor can verify their physical condition if needed.

Participant grants permission for use of their name and/or photograph or voice in broadcast, telecast, print, or any other account of this event.

Participant agrees to collect the required fundraising minimum for AACR by stipulated deadline. If participant has not reached the minimum in sponsorship by that date, they will be personally responsible for the balance owed and will ensure their credit card information provided is current and active to charge the remaining balance. If the fundraising minimum is not met and up-to-date credit card information is not provided, AACR reserves the right to pursue collection of the outstanding debt balance by any lawful means, including but not limited to third-party collection agencies or legal action. The participant will be fully responsible for all legal fees incurred with this collection process. If participant reneges on their financial responsibility to AACR they will be reported to The Philadelphia City Fund which may result in a ban from future Philadelphia Marathon Weekend events.
