

In compliance with the standards set by the Accreditation Council for Continuing Medical Education (ACCME), it is the policy of the American Association for Cancer Research (AACR) and Partners for Advancing Clinical Education (Partners) that the information presented at CME activities will be unbiased and based on scientific evidence.
